Information for Guardians

What are the grade-level specific student expectations?

<u>High School 9-12+ Student Expectations:</u>

- High School 9-12+ students will utilize Edgenuity online platform and google classroom as directed by individual teachers for courses that are not on Edgenuity. Physical Education will be continued through Edgenuity. Lessons will be available daily by 10:00 a.m.
- 2. Both Edgenuity and Google Classroom are accessible through a variety of devices such as desktops, laptops, cell phones, tablets and gaming devices with internet access. Assignments should not need to be printed out to be completed.
- 3. The goal is 40 minutes per course per day. Students will turn in the work assigned on the day due, any work not completed during by the due date will need to be made up.
- 4. Teachers will be available to engage with and support students between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google classroom, google hangout, Edgenuity and scheduled phone conference.
- 5. Teachers will be available to support students and consult with guardians between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google classroom, google hangout, Edgenuity and scheduled phone conference.
- 6. Program therapists will be available to support students and consult with guardians between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google hangout and scheduled phone conference as needed.
- Speech and Language Pathologists and Occupational Therapists will be available by email and scheduled phone conference as needed for consultation to guardians.

Middle School 6-8 Student Expectations:



- 1. Middle School student's guardians will receive a calendar learning activities in core subject areas (ELA, Math, Science, Social Studies) through email.
- 2. Lessons will be available by 10:00 a.m. daily. Students in grades 6-8 should choose 3-4 learning activities per day. Assignments should not need to be printed out to be completed.
- 3. The goal is 20 minutes of learning activities per subject per day. Guardians will be expected to report completed activities through email at least weekly, any work not completed during the school closure will need to be made up.
- 4. Teachers will be available to support students and consult with guardians between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google classroom, google hangout and scheduled phone conference.
- 5. Program therapists will be available to support students and consult with guardians between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google hangout and scheduled phone conference as needed.
- Speech and Language Pathologists and Occupational Therapists will be available by email and scheduled phone conference as needed for consultation to guardians.

Elementary School K-5 Student Expectations

- 1. Elementary School student's guardians will receive a matrix/calendar learning activities through email.
- 2. Lessons will be available by 10:00 a.m daily. Students in grades K-5 should choose 2-3 learning activities per day. Assignments should not need to be printed out to be completed.
- 3. The goal is 30 minutes or more of learning activities per day. Guardians will be expected to report completed activities through email at least weekly.
- 4. Teachers will be available to support students and consult with guardians between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google classroom, google hangout and scheduled phone conference.
- 5. Program therapists will be available to support students and consult with guardians between 10 a.m. and 3 p.m., Monday-Friday during the duration of the school closure. This can be done through a combination of email, google hangout and scheduled phone conference as needed.



6. Speech and Language Pathologists and Occupational Therapists will be available by email and scheduled phone conference as needed for consultation to guardians.
